- **C25007827** – 3/12/2025 – 1950 hours – Involving Austin Bennett (Primary) and Spencer Trop. This was Austin's very first day on his own (Phase 3). He was patrolling the area of the Safeway parking lot located at 15500 Aurora AVE N when a lady flagged him down in the parking lot stating that there was a male down behind the Chevron (across the street) unconscious with a light pulse. Austin followed his training perfectly here: checking for a pulse, getting close to his airway (to check for breath) while also supporting the man's head. Recognizing the immediate need for a Narcan deployment, Austin grabbed a Narcan that he already had in a deployment pouch on his person, ripped it open, and began deploying it just as we are trained. While continuing to support the victim's head in place and applying a sternum rub, Austin slowly saw the male victim come back to life, eventually breathing normally. Deputy Trop arrived on scene at this time and recognized the need to have the man be placed in a recovery position as Deputy Trop and Deputy Bennett continued to support the man's head and body as he came back to life. Watching the BWC of this incident was incredibly impactful. It once again reminded me of the amazing work that our Shoreline Deputies do out there every day. There is no doubt in my mind that Austin Bennett and Spencer Trop saved that man's life that night. Credit to both of them for their astounding work

ethic and constant selfless nature, as both of these Deputies love to serve our communities and give it everything. A truly great thing to see!

- 3-15-25 1815hrs **C25008141**- 2B responded to a D.V. involving a weapon. Patrol Deputies set up a perimeter on the house as well as an arrest/rescue team. They were able to get the victim and all other innocents out of the house leaving just the suspect inside. As additional resources were enroute to the location patrol Deputies were able to talk the suspect out of the house. Deputy Mainaga then completed a search warrant for the residence to recover evidence items. Several firearms as well as an AR-15 rifle loaded with "Green Tip" piercing rounds were recovered from the scene.
- 3-21-25 2030hrs **C25008177**-. A traffic complaint came in about a reckless driver. Deputy Planalp recognized this car from other broadcasts in the week and also knew that during a DUI emphasis in Shoreline the vehicle had taken off from the Police. Deputy Planalp was able to locate the vehicle a short time later and coordinated with the Shoreline SET team to keep eyes on the vehicle. As additional resources were coming into the area the suspect started to walk towards his vehicle, Deputy Planalp made a quick decision to block in the vehicle on his own and conduct an open air takedown on the subject to prevent another pursuit. The individual was then taken into custody a short time later. This is a great example of an individual who had been causing danger to the community with his reckless driving behavior.
