#### **Notable Incidents:**

7/27/25 Robbery with a knife. The victim was hit with a flashlight and cut with a knife on his forearm, causing minor injury. The suspects were not located and the investigation is ongoing.

7/29/25 Threats to judge. The suspect threatened a King County District Court Judge and Shoreline's persecuting attorney. The suspect was arrested on 8/6/25 by Shoreline detectives.

7/7/25 Felony Domestic Violence Assault. A husband and wife got into an argument. The husband feloniously assaulted the wife and was arrested by officers.

7/7/25 Fraud. A couple was scammed out of \$70,000.

7/9/25 Assault. The victim was assaulted after a hit and run collision between two vehicles. Victim followed the other vehicle and got into an altercation where the suspect injured the victim's hand.

7/11/25 An unknown explosive device was detonated in a cigarette butt receptacle and a trash can at Shoreline Community College.

7/20/25 Assault on officer. A Shoreline officer observed a male jaywalking on Aurora and went to stop him. The suspect hit the officer in the side of the head and ran away. The officer caught up and the suspect resisted being placed under arrest. Multiple Shoreline officers arrived and placed the suspect under arrest for assault. The officer was taken to the hospital with minor injuries and took a few days off for recovery.
