Deputies Aid Firefighters in Apartment Blaze

On 08/26/2025, Deputy Dromgool on-viewed a large fire at the Junction 160 Apartments in Shoreline where he found at least three units were heavily on fire on multiple floors. He advised dispatch and then immediately started working to ensure the building got evacuated. With no hesitation he immediately entered the building and went door-to-door to every unit on every floor announcing the fire and ensuring residents were evacuating the building.



Deputy Osborne soon arrived to assist and was asked by a Shoreline Fire engineer to assist in getting a feeder hose hooked to a hydrant. Without hesitation he took the line from the truck and routed it to the hydrant and then proceeded to use the tools and fittings bundled in the hose to hook the hose to the hydrant and turn on the water. I later learned that he had spent time in a Fire Explorers program in his youth. Because of this, he was familiar with the equipment and procedures and

used his knowledge and skills to assist the engineer in getting water to the engine. Deputies Bergeron and Trop arrived and assisted in keeping the area clear for Shoreline Fire to work and in gathering information that would later be needed by the fire investigators.

After the incident I was approached by multiple Shoreline Fire personnel who expressed gratitude for the assistance provided by these deputies that made their job easier. I would like to recognize that Deputies Dromgool, Osborne, Bergeron, and Trop all demonstrated great professionalism, teamwork, interagency cooperation, and dedication to serving the community. They represented the Shoreline Police Department and the King County Sheriff's Office with outstanding performance.

Detective Volpe Solves Knife Assault Case



At 3:36 AM on August 7, 2025, a man called 911 to report he had just been assaulted while on his way to work at Costco in Aurora Village. Upon arriving at work, he realized he had not only been punched but also stabbed.

Due to the extensive and diligent work of Detective Matt Volpe, the suspect was identified, located and charged with Assault 2. Renton Police had booked him into the Maleng Regional Justice Center on August 22, and now

he faces additional charges for the Shoreline assault. Bail has been set at \$125,000.00.


The victim expressed his sincere gratitude to Detective Volpe, describing him as "kind and professional in every aspect of my case," and appreciated the follow-up support and contact information he provided. He shared that he is recovering well and hopes the suspect receives the help he needs while in custody.
