Highlights:

In late August, Deputy Maria Liberta was dispatched to a vehicle theft at a construction site involving a stolen 420 Skid Steer front loader and trailer. The case was assigned to Detective Joshua Gedney.

The victim located it on Facebook Marketplace and notified Detective Gedney. A meet up was arranged with the suspects and last week, MPO Ryan Cullen and CID detectives arrested them at the scene without incident. MPO Cullen transported both to King County Jail, where they were booked for possession of stolen property and trafficking stolen property.

Detective Gedney also served a search warrant on the Toyota Tundra used to haul the stolen loader. The vehicle was reported stolen in a separate Seattle Police case. A search recovered a semi-automatic handgun, ammunition, and illegal drugs.

Community Outreach Detective - Velie

Det. Velie returned to partial hours, light duty the middle of September.

Violent Crimes and Trafficking Detective - Finan

- Completed 20 outside agency assists relating to social media, gang, and human trafficking intelligence.
- The FBI human trafficking task force received a tip about a juvenile trafficking victim. Det. Finan was able to identify the victim for the FBI and provided them with her social media accounts.
- KCSO Assists:
 - Det. Finan found a social media image of the primary suspect in a robbery series assigned to MCU. The suspect was wearing the exact same outfit worn during the robbery. He provided MCU with information of the suspect's gang and associates.
 - Assisted Det. Volpe with the initial fact finding in his Shorewood HS assault case. Helped Det. Volpe with the social media aspects of the case.
 - IFIT response: On 08/30/25, he responded to an IFIT call-out in Renton to assist with the investigation. Kent PD was primary on the case.
 - Helped teach TDA Deputy advanced investigative techniques while he was on a 2-week assignment in the CID office.
- Cases:

- C25028368 Extortion: Involved threats made on Instagram. Followed up with the victim and found the incident to be an attempted scam utilizing social media extortion methods.
 Determined the accounts were fake and likely created by foreign scammers.
- C25025054 Drive-By Shooting: Early morning drive-by shooting on 18000 block of Aurora.
 Attempted to ID suspect vehicle via databases and through regional partners. No victim came forward.
- **C25027660 PSV:** Assigned case for filing after a patrol arrest. Helped TDA Deputy work through the follow-up investigation process and showed him various avenues to pursue in trying to identify the original vehicle theft suspect(s). Completed the follow up for the case.
- **C25028289 Assault 2:** Juvenile assault case. Suspect stabbed victim in the neck with a pencil. Completed the investigation and referred Assault-2 charges on the 12-year-old suspect.
- C25011871 Human Trafficking: Submitted Instagram warrant relating to a runaway 15-yearold trafficking victim and her suspected pimp. Warrant return confirmed the pimp's involvement in trafficking the juvenile. Working with the prosecutor's office on next steps for filing Promoting CSAM charges.
- C25003891 & C25004162 MV Theft (UPDATE): Suspect in this case pled guilty MV Theft & ID Theft in this case as part of a global resolution. He received a 36-month prison sentence + 36-month DOSA probation.
- C24030081 Human Trafficking (UPDATE): Suspect had his bail reduction hearing and was asking for release to home monitoring and drug rehab. Det. Finan wrote a 27-page evidentiary supplemental report chronicling the evidence. The supplemental was presented to the prosecutor and the judge prior to the bail reduction hearing. The judge denied release and kept bail at \$425k.
