#### Highlights:

In late August, Deputy Maria Liberta was dispatched to a vehicle theft at a construction site involving a stolen 420 Skid Steer front loader and trailer. The case was assigned to Detective Joshua Gedney.

On 10/2/2025 The victim located it on Facebook Marketplace and notified Detective Gedney. A meet up was arranged with the suspects and last week, MPO Ryan Cullen and CID detectives arrested them at the scene without incident. MPO Cullen transported both to King County Jail, where they were booked for possession of stolen property and trafficking stolen property.

Detective Gedney also served a search warrant on the Toyota Tundra used to haul the stolen loader. The vehicle was reported to have been stolen in a separate Seattle Police case. A search recovered a semi-automatic handgun, ammunition, and illegal drugs.

#### <u>Violent Crimes and Trafficking Detective</u>

Completed 17 outside agency assists relating to social media, gang, and human trafficking intelligence.

Represented Shoreline Police and KCSO as an instructor at the Eastside Investigations School (attendees from Lakewood, Renton, Issaquah, Bellevue, Kirkland, Redmond, Sno Co, and Everett PDs) where he taught a 90-minute class on Social Media Investigations.

Completed 2-day Force Science training class as part of IFIT.

Assisted SPD Homicide on their gang related murder in Northgate. Identified and quickly preserved six Instagram accounts relating to the suspect and victim in the case.

At her request, met with MDOP (Most Dangerous Offender Program) prosecutor Aubony Burns and provided her with gang intel relating to multiple open King County MDOP cases.

**KCSO Assists:** 

- Taught a 75-minute Social Media Investigations class at Det-1 school for MCU Det. Peckham
- Identified multiple traffickers and trafficking victims based on the monikers given to Seatac Det. Short by a source.
- Based on intel received by Det. Short, Det. Finan created an in-depth intel report relating to the new ownership group of the strip club (Club Dollhouse) located at 10338 Aurora Ave N.
   The club is allegedly allowing juveniles to be trafficked inside. Provided the intel to SPD, Det. Short, and the prosecutor's office.
- Identified the gang member and suspected shooter in Det. Olmstead's case and provided him with the suspect's social media
- Assisted MCU by retrieving surveillance video related to Shoreline Homicide.
- Assisted MCU Det. Bruce with intel relating to one of her shooting cases.

## Cases:

- **C25028289 Assault:** Assault involving two Einstein MS students. Suspect stabbed the victim in the neck with a pencil. Referred Assault-2 charge to the juvenile court.
- C25029995 Attempted Robbery: Completed rush file on attempted robbery of the Shell
  gas station which was interrupted by Deputy Planalp. Wrote vehicle and cell phone warrants
  for the case. Both suspects charged with Attempt Rob-1, and one suspect charged with
  UPFA-1.
- C25030083 DV Order Violation: Assigned case for filing after a patrol arrest. Determined
  there was PC to arrest the suspect for one count of Felony NCO Violation and one count of
  Misdemeanor NCO Violation. Amended the primary narrative for the case and completed
  the filing.
- C25028289 UPFA: Chief Collins received info from a citizen who saw a juvenile post a
  Glock switch on social media. He identified the juvenile as an Einstein MS student,
  documented his social media accounts, alerted the school, interviewed his mother, and was
  able to get mom to confirm there were no firearms hidden in her residence. He completed
  an informational report.
