Notable Incidents:

C25032447: Homicide investigation in the 20100 block of Whitman Ave N. Callers reported hearing gunshots and found a female in the street with gunshot wounds. Aid was provided to the female but she died of her injuries. The suspect was eventually located and confessed to the homicide. He was booked into King County Jail.

C25032756: Death of a child at Ashley House. Officers received a call of an AED request for a child. Medical Aid was provided but the child died. An investigation was conducted and it was determined there was nothing suspicious. Officers were provided assistance through KCSO Peer Support.

C25030925: Assault with a firearm. Caller reported that her ex-husband hit her with a bottle and pointed a firearm at her mother. While enroute, someone took the firearm away and fled the scene. Officers arrived and arrested the suspect for felony assault. He was booking into King County Jail.
