On 06/20/2020 at about 1640hrs while on patrol in Shoreline as 2A0, I responded to what was reported as a hate crime located at [REDACTED] Shoreline, WA.

This call is related to a call I responded to last week under CAD number K20203380 regarding a "Black Lives Matter" sign that was placed in the yard of O2 [REDACTED] [REDACTED] had a "Thin Blue Line" flag on the front of her house and reported that someone had placed a sign that said "Black Lives Matter" and "Fuck the police" in her yard.

I contacted 13YO SB1-[REDACTED] and her aunt, O1-[REDACTED] and [REDACTED] stepped out of the house holding a couple pieces of paper. [REDACTED] told me that the paper was her "statement" and that it was a letter to the neighborhood. I asked them to tell me what had happened and [REDACTED] began reading off of the paper.

[REDACTED] stated that on 07/14/2020, her neighbor, later identified as [REDACTED] had a "racist" flag out in front of her house, located at [REDACTED] 9<sup>th</sup> Ave NE, Shoreline, WA. [REDACTED] said that she put a "Black Lives Matter" sign in [REDACTED] yard and admits to putting the sign on her property. [REDACTED] stated that the next day, she drew "Black Lives Matter" in chalk in front of [REDACTED] house.

[REDACTED] then stated that she rode her bicycle by [REDACTED] house later and that [REDACTED] "stared" at her. [REDACTED] said that she yelled "F the police". [REDACTED] said she went back out later in the evening and put another "Black Lives Matter" sign in front of [REDACTED] house.

[REDACTED] stated that on 07/16/2020 at 0640hrs, she placed another "Black Lives Matter" sign across the street from [REDACTED] house. Then, at about 1430hrs that same day, [REDACTED] states that she made a sign that read "Am I next" and "Defund the police" with red handprints. [REDACTED] stood in the street outside [REDACTED] house with the sign.

[REDACTED] then alleges that another neighbor that lives at [REDACTED] 9<sup>th</sup> Ave NE, Shoreline, WA, later identified as SB2-[REDACTED], tried to hit her with her car. [REDACTED] states that [REDACTED] would have hit her if she hadn't moved out of the way. [REDACTED] states that [REDACTED] backed into her driveway and then yelled at her. [REDACTED] alleges that [REDACTED] yelled at her "If you put some Black Lives Matter shit near my house, I'll shoot you".

[REDACTED] then stated that on 07/17/2020 at 0650hrs and on 07/18/2020 at 0530hrs she put "Black Power" signs in front of [REDACTED] house.

I asked [REDACTED] if she felt that [REDACTED] would carry out the threat and [REDACTED] said "No, but yes". I asked [REDACTED] what "no, but yes" meant. [REDACTED] stated that she didn't think [REDACTED] would shoot her "because of the consequences" but thought that she was mentally unstable.

[REDACTED] and [REDACTED] gave me a copy of the letter [REDACTED] had written. I advised [REDACTED] and [REDACTED] that I would document their case and provided them with the case number.

I contacted [REDACTED] at her residence and asked her to tell me her side of the story. [REDACTED] stated that her neighbor, [REDACTED] has been upset over the signs that had been placed in her yard and that it also made her upset because [REDACTED] was afraid. [REDACTED] stated that she had driven home and saw [REDACTED] at the end of the neighbor's driveway. [REDACTED] said that she always backs into her driveway and starts by swinging out into the road before backing in and that she was not close to hitting [REDACTED]

[REDACTED] admits to exchanging words with [REDACTED] and said that the things she said were said out of anger. [REDACTED] stated that during this exchange, [REDACTED] mentioned calling the police, to which [REDACTED] allegedly responded with something to the effect of, "Don't call the police, they'll shoot me". [REDACTED] admitted that she told [REDACTED] something along the lines of, "If you creep around my property at night, it's not the police you need to worry about". [REDACTED] added that she made those statements out of "anger and frustration" and that she wouldn't carry out the threat. [REDACTED] stated that she would be willing to speak with [REDACTED] but doesn't know where she lives.

On 7-21-2020 at approximately 0703 hours I was dispatched to a neighbor problem at [REDACTED] 9<sup>th</sup> Ave NE, where [REDACTED] [REDACTED] wanted to speak with an officer regarding an incident that occurred on 7/16/2020 with 13YO, [REDACTED] [REDACTED]. This incident was reported by [REDACTED] and her aunt [REDACTED] [REDACTED] on 7/20/2020. Reference Deputy Swanson's supplemental report for further details.

On scene, [REDACTED] summarized the incident for me. She was coming home from work and saw [REDACTED] in the street in front of her neighbor home, [REDACTED] 9<sup>th</sup> Ave NE. She saw that she was holding up a "Black Lives Matter" sign. She continued as she normally does and backed her vehicle into her driveway giving plenty of room to [REDACTED]. When she exited the vehicle she went up to [REDACTED] and approximately 10 feet away from her she attempted to talk with [REDACTED] regarding her stances and views on Black Lives Matter. [REDACTED] stated the conversation became "heated" very quickly and as words were exchanged she became "frustrated and angry" because [REDACTED] wasn't attempting to engage in the conversation. In [REDACTED] frustration she asked [REDACTED] "what the fuck is wrong with you?" and told her "if you come on my property you don't need to worry about the police". [REDACTED] admitted that she was very upset at the time and that her emotions got the better of her. She was upset not only because she was angry about the lack of conversation from [REDACTED] but for her neighbor, [REDACTED] who had been getting harassed by [REDACTED] the past few days because [REDACTED] had a "Thin Blue Line" flag in their front yard. [REDACTED] wanted me to know she doesn't know [REDACTED] doesn't know where she lives and has never interacted with her before.

[REDACTED] then provided me a letter which was typed by [REDACTED] and overviews the events from 7/14 - 7/18 with both [REDACTED] address, [REDACTED] 9<sup>th</sup> Ave NE and [REDACTED] address, [REDACTED] 9<sup>th</sup> Ave NE with the interactions between her and the two neighbors. This letter is attached to Deputy Swanson's supplemental report. [REDACTED] wanted to speak with me about this letter and mention that she never threatened [REDACTED]. That she never told her she was going to come to her house and that she at her when she spoke with [REDACTED] [REDACTED] stated most of the letter that quotes her is incorrect. She wanted to emphasize with me that her intent in talking with [REDACTED] was only to generate conversation. [REDACTED] was also upset over the remarks in the letter that talked about her almost hitting [REDACTED] with her vehicle. In regards to this, I spoke with another neighbor, [REDACTED], who informed me that she saw [REDACTED] coming home and parking her car. She let me know that [REDACTED] car was nowhere close to [REDACTED]. [REDACTED] also mentioned that one of the "Black Lives Matter" signs [REDACTED] placed on [REDACTED] yard had written on the back "fuck the police", "oink oink oink" and possibly other negative language regarding law enforcement. [REDACTED] told me a sign was left in front of her house with the front of the sign facing [REDACTED] house saying "Blue Lives Murder".

[REDACTED] also brought to my attention that a facebook post from [REDACTED] mother, [REDACTED] [REDACTED] on 7/20/20 regarding the incidents with [REDACTED] & [REDACTED] writes "We gathered more information, the threat of lynching and shooting was witnessed by someone and we are reporting it as a hate crime." [REDACTED] is involved with Black Lives Matter - Shoreline and we will be planning a demonstration in the next day or two on our street, to let her neighbors, our neighbors know this is unacceptable." The post continues to outline that [REDACTED] or [REDACTED] was able to get her neighbor to remove the blue lives matter flag and states "In the process of this, another neighbor took offense to this long girl's protest. She tried to hit [REDACTED] who was standing in the street with a BLM sign, with her car. She got out and screamed at [REDACTED] and said all kinds of weird ridiculous things to her about [REDACTED] being racist for saying Black lives don't matter. She attempted to get other neighbors involved. She then threatened to lynch and shoot [REDACTED] if she put a sign near her property. She threatened to harm a 13 year old Black girl for saying that HER life matters on her own." The post continues to outline their family's history in the Ridgecrest neighborhood of Shoreline and the spectrum of racism and discrimination they have faced over the years. [REDACTED] continued with "We are planning a peaceful, purposeful, healing, empowering demonstration this Saturday. Details to come as planning is happening right now but we need those in Shoreline committed to anti racism to show up to let the community know racism is unacceptable.

her neighborhood with people walking by who she is not familiar with since the facebook post went up. I provided [REDACTED] the option of possibly getting an anti-harassment order because of the grief she was feeling and her sense of safety was of concern. She stated she did not want to do that because that may "escalate" the situation.

[REDACTED] was able to provide me other facebook posts in reference to the incident and rumors of gatherings/protests in Shoreline this week, possibly around Paramount School Park.

On 07/23/2020 at about 1614hrs while on patrol in Shoreline as 2A0, initiated a follow-up by phone call to O- [REDACTED].

I asked [REDACTED] if she wanted to provide a statement detailing what happened at her property and in the neighborhood. While speaking with me, [REDACTED] would occasionally sound as if she was starting to cry, and would apologize, stating that she was very stressed. [REDACTED] said, "I'm just scared" and stated that she didn't want to "escalate" the situation with her neighbors. Because she didn't want to "escalate" the situation, [REDACTED] was hesitant to provide a statement, but told me that she would think about it and call back if she wanted to provide one.

During our conversation, [REDACTED] stated that she had hung a "thin blue line" flag in honor of the Bothell Police officer who was killed in the line of duty. [REDACTED] said that the "Black Lives Matter" sign appeared in her yard along with one that said "Fuck the police" and "Oink oink". [REDACTED] added that she didn't understand why the signs were appearing on her property.

[REDACTED] stated that signs saying "Black Lives Matter" and "#blackpower" also appeared in her yard. One stating "Blue lives matter murderer" appeared across the street. [REDACTED] added that a "young woman" rode by her house on a bicycle and yelled, "Fuck you!" and other things at her. [REDACTED] said that she later learned that the young woman was 13 years old. [REDACTED] stated that she tried to pursue an order against her, but was unable to do so as she does not know who the young woman is.

End of follow-up.

On 8-7-2020 at approximately 0900 hours I spoke with [REDACTED] regarding the events detailed in C20022893. [REDACTED] provided me a statement over the phone which I typed out for her. In it she details the conversation with her and [REDACTED] on the original date of the incident. She stated she did not attempt to hit [REDACTED] with her car and that her conversation was only meant to be civil with her trying to understand what [REDACTED] was doing in front of her neighbor's house and why [REDACTED] kept insisting her neighbor, [REDACTED] was racist for putting up a thin blue line flag on her property. The subsequent actions from [REDACTED] have been gathering people for a march/protest in conjunction with Black Lives Matter-Shoreline with continued gatherings in the intersection of NE 160<sup>th</sup> St /9<sup>th</sup> Ave NE starting back up on 8-6-2020.

I was informed last night after I was off shift that [REDACTED] was sent an instagram post from an Instagram profile - BlackPowerStudents. [REDACTED] informed me this account is [REDACTED] public profile but she also has a private profile. [REDACTED] specifically sent me a post that read "This is [REDACTED]. The woman who threatened to shoot & lynch me and tried to hit me with her car. I could care less about her privacy, this is your neighbor." The post also have a photograph of [REDACTED] and her dogs on it. [REDACTED] was very upset over this post and other social media posts that suggest she did these terrible things when they are not true. [REDACTED] provided me additional Facebook posts on her page where random strangers have commented calling her a "racist" and that she does not "deserve peace". She has since made her social media accounts fully private. [REDACTED] is afraid of what might happen next and is scared that her, her family and property may be in danger. She stated the intent of these social media posts have been made with the intent to harass and intimidate her and her family. [REDACTED] stated she is willing to assist with prosecution of a crime.

I am sending this case to the King County Juvenile Prosecutor for review and I am recommending one count of RCW 9.61.260; Cyberstalking be charged to [REDACTED]

**Dear all my Ninth AVE neighbors**

Recently I was victim to a racist hate crime on this block, I wrote about all what happened leading up to it and what happened during it. As a thirteen year old Black girl in Shoreline I am not surprised any of this happened. Shoreline likes to say how "Progressive" they are when in reality they are not one bit. I am the third generation of my family to live on this street and in the same house. My white passing great grandfather (who was Black and Native) bought this house when it was a redline district. In this neighborhood I have been bullied, followed home and now threatened. Please read this and hear what I went through as a Black Girl in Shoreline. This is your neighbor who threatened my life, and people need to know. I will not be silent about this.

(This is letter is only shared with residents of Ninth AVE)

**Tuesday July 14th 2020**

Early in the Afternoon: Me and my mom saw a Blue Lives Matter Flag at our neighbors house (██████). My mom stopped the car and looked to see if it really was that flag. (it was) Before we drove off the Lady looked at us and laughed. ( I don't know her name 100% but from what her friend was saying I think it's █████ or █████ or █████ )

Later That Evening: I made a sign saying "Black Lives Matter" and put it on her property. This was the first and only time was on her property, or anyone's property. Yes I know it was not right and I am willing to admit it was wrong and not do it again.

**Wednesday July 15th**

12 in the afternoon: Me and my friend drew "Black Lives Matter" in chalk in front of her house.

Mid afternoon: I was riding my bike for fun around my neighborhood and came across her house. She was on the porch and stood up and stared at me. I was worried and uncomfortable by that so I pointed at her flag and yelled "F the police" not cussing, only saying the letter itself.

Later that evening: I went and put another "Black Lives Matter" sign in front of her house not on her property.

**Thursday July 16th: The Day of the Hate Crime**

6:40 in the morning: I put another "Black Lives Matter" sign across the street from her house not going on anyone's private property.

**2:30 in the afternoon:** I made a sign saying "Am I next" with red handprints and "Defund the police". I rode my bike down to her house and stood out on the street with my sign.

She and her friend (another neighbor whose name and address I do not know) sat on her porch saying that "I'm immature for what I'm doing" and "I should of came and had a conversation with her like a real woman instead of being stupid" she then proceded to tell me how very sorry she is for me and tell her next door neighbors (to the south, [REDACTED]) that I was the one putting up signs and that they finally "caught" me. Another kid riding her bike asked what I was doing, I explained to her and she said she would stay but had to get home. After the girl left and The woman told me that she has black friends so she's not racist, She has black family so she's not racist. She then told me I made her black friend cry and her police friend cry. She said I had no disregard for any black people but myself and that I'm a selfish, stuck up brat. I still didn't say anything. Another neighbor, [REDACTED] The one who threatened me, Her house: [REDACTED] turned the corner to come home to her house. She saw me and sped up and served near me and backed up, if I hadn't moved in time she would have hit me, it was clear that it was her intention to hit me. She backed into her driveway and got out of her car and started yelling at me "What the f\*ck is wrong with you". "You dumba\*ss child". She kept yelling at me and cussing at me. She turned to my neighbors on their porch and started talking about me to them. "She's just a dumb child" "She's a scared little girl" "She can't do anything, She has no power". She turned to me and yelled those same things in my face. I didn't say anything but I did put up the Black power fist. She said "Black power my a\*\*" She said that I was implying that Black lives don't matter by what I was doing and that I was being a selfish baby, only thinking about myself. She said that I would probably be happy if "I was the next one to be shot by police" and if she was a police officer she would happily shoot and lynch me. This man walking his dog stopped to see what was happening but I didn't pay attention to him. The lady kept yelling at me how spoiled I was and how she LET Black EMTs into her house to save her disabled son's life so she's not racist. She started clapping in my face asking me if she was to come to my house, would I care/ have a problem with it? I tried to answer but she kept clapping in my face and yelling. I tried to get my phone out to film but I was scared and didn't want to move. She yelled very loud "If you put some Black Lives matter sh\*t near my house I'll shoot you". The man yelled at her "Now you're just threatening her". He started yelling at all three of the women and told me to go home so I would be safe. I didn't know who he was or what happened after I left.

**Friday July 17**

6:50 in the morning: I put a sign across the street from both houses saying "I will not be silenced" and "Black Power".

**Saturday July 18**

5:30 in the morning: I put a "Black Power" sign in front of [REDACTED]'s house not at all going on her property with a note attached saying who I am, what activism work I've done in Shoreline and that she will not silence my Black voice.

**To all my white and non Black neighbors,**

I am asking that you do not do any actions such as vandalizing her house or anything of the sort. I'm better than that and wouldn't wish that on anyone. I am asking you to see what I go through as a Black girl in Shoreline. I want all of you to know that your neighbor [REDACTED] tried to hit me with her car and threatened my life. I am not doing this for attention or sympathy, I am doing this because this racist woman will not get away with committing a racist hate crime against a Black teen. This woman has yet to apologize or come forward to me or my family at all. Even though no amount of apologies or sympathy can take away the trauma I am asking that all of you make sure this woman doesn't do anything to harm me or my family. She threatened to come to my house. She has caused so much trauma to me and my family and I do not want to let her get away with this without her neighbors knowing what she has done.

We thankfully have people who will put pressure on Shoreline police to investigate this fully. Boo is involved with Black Lives Matter - Shoreline and we will be planning a demonstration in the next day or two on our street, to let her neighbors, our neighbors know this is unacceptable. We're reaching out now to our neighbors with a letter Boo wrote that I hope she'll let me share here. I've let her know about everyone's response her and she feels y'all's love and support so thank you\*

This week a neighbor hung their blue lives matter flag outside their house. Boo and I were shook, badly. Boo decided on her own to protest this and the neighbor took the flag down after talking to Boo.

In the process of this, another neighbor took offense to this lone girl's protest. She tried to hit Boo, who was standing in the street with a BLM sign, with her car. She got out and screamed at Boo and said all kinds of weird ridiculous things to her about Boo being racist for saying Black lives don't matter. She attempted to get other

neighbors involved. She then threatened to lynch and shoot Boo if she put a sign near her property. She threatened to harm a 13 year old Black girl for saying that HER life matters on her own.

This is in Shoreline, the Ridgecrest neighborhood where our family has lived since 1950. My passing grandpa bought a house here in Redline Shoreline and promptly moved his very brown family in. He gave us the gift of a generational nest egg but it has come at a cost, we have faced a wide spectrum of racism and discrimination over the years in Shoreline. Some may say it's gotten better but those of us who know, know that it's just gotten more insidious, quieter but still as deadly. And now we have a neighbor who has committed a hate crime against a 13 year old peacefully protesting and making sure her neighbors know that her life does matter.

We are planning a peaceful, purposeful, healing, empowering demonstration this Saturday. Details to come as planning is happening right now but we need those in Shoreline committed to anti racism to show up to let the community know racism is unacceptable.

All of it started when my next door neighbor wanted to honor Officer Schoop who had been killed in the line of duty with a thin blue line flag on her house. She received a couple of "Black Lives Matter" signs on her property. One of the signs had on the back "fuck the police" "blue lives murder" "oink oink oink". After getting these signs she started seeing "Black Lives Matter" chalked in front of her house on the street. She called and reported these incidents to police. The next day her and her boyfriend were in front of their house and saw a young lady on a bike. The second time the same young lady came by she said "fuck the police" "blue lives murder" "fuck you" and flipped them off. They both made the deduction that whoever this young lady was is possibly the same person placing signs on their property and doing the chalking.

The following day, as I was coming home from work, I saw a young lady standing at the front of my neighbor's driveway holding a sign. The sign said "am I next" and "defund the police". My next door neighbor and another neighbor were sitting on the front porch. She saw me driving to back into my driveway and she did not move from her position. I got out of my car and stood 10 feet away from the young lady and asked her "can I help you?" She did not respond. I asked "I'm sorry maybe you didn't hear me. How can I help you?" She responded with "Black Power" with her fist in the air. I thought it was an odd response to my question. I told her "I don't know what's going on, can you help me understand." She responded "your neighbor is a racist and she wants to kill me." I asked her if she knew my neighbor and she said "no". I asked if she has ever talked with my neighbor and she said "your neighbor doesn't want me on her property". I asked her, if she was the person who was chalking the street and placing signs on my neighbor's property. She admitted to me "yes". I asked her "do you blame her for not wanting to talk to you?" She told me "yes I blame her because the flag was racist and she wants all police to kill black people". I asked her "how would you feel if someone had gone to your home and did these things to your house?" She responded "I'd be fine with it." I told her "you'd be okay with people putting harassing signs at your house? Because if you're saying "defund the police" then they wouldn't have the resources to help you." I asked

her another question, "god forbid if something happens to you at your house who would you call?" She responded "I'd call the police but they'd probably come to my house and kill me because I'm Black". I told her that if I call 9-1-1 that these services would be available to help me. I told her that some of her thoughts were hypocritical. She responded "well my life matters". I told her I don't think anyone ever said her life didn't matter. I told her "you're a human being". She responded "well you neighbor doesn't think my life matters because she is a racist and supports the police".

She then started crying and started naming off people who had been killed by police. I told her that I am just like you, I am disgusted and mortified with what happened to the people she was naming off and that they deserved to be treated better. I told her that she cannot lump people in a group and that police officers are here to help people. A random person across the street was listening in and I continued to attempt to have a civil conversation with the young lady. She continued with responding with all people who support police are racist and that "they" all wanted police to kill them. I started to get upset with how the conversation was going. I told her I was finished with attempting to talk with her because she was not having a civil conversation with me. Before I left, I told her "If I find your crap in my yard, you won't have to worry about the police, you and I will have a personal problem." Then I went inside my house.

After I went inside the man standing across the street started to yell at the neighbors regarding the meaning of the thin blue line flag. I saw the young lady walk over to the man and they started to talk with each other.

Since then, the young lady, [REDACTED] have organized a march/protest with Black Lives Matter-Shoreline. I was advised by officers that it would be best if I was not there because I was specifically being targeted as the reason for the march. I took my family and left my home for the day. Things started to quiet down after the march but every once in a while random people will drive by screaming "Black Lives Matter" at our house. I found out online that spray paint of "Oil Lies Mater" was sprayed on the [REDACTED]'s easement. The narrative that went with it "a few weeks ago a Black child was threatened to be shot and lynched by a neighbor in the Shoreline area. After community members responded with direct action. The same child is being harassed by same members of this community. Believed to be affiliated with the same individual that threatened the child. I completely believed, 100%, they believe I was the one that did this and that I threatened [REDACTED]. It is very scary because, now I'm being accused of things again that I did not do. I don't drive near their home, I don't drive near the section near NE 160<sup>th</sup> St/9<sup>th</sup> Ave NE. Basically I don't drive down 9<sup>th</sup> Ave NE between NE 160<sup>th</sup> ST – NE 165<sup>th</sup> St because of what is happening. I don't take my dogs for walks anymore because I don't feel safe in my own neighborhood. I rarely go anywhere without another person with me because I don't feel safe in my own community. I went at this trying to understand someone and trying to help and it has been construed that I have done all



these terrible things. They have completely gone through and changed everything that was said. I further looked into more social media regarding the activity on 9<sup>th</sup> Ave NE. I found out last night on 8/6/20 that an Instagram post directly naming me with a picture of me and my dogs says "This is [REDACTED] The woman who threatened to shoot & lynch me and tried to hit me with her car. I could care less about her privacy, this is your neighbor." This post makes me feel upset, made me concerned, it made me very scared. This post and others like it have the direct intent to harass me, and intimidate me. [REDACTED] has publicly put out my name and address to others and now my likeness is associated. I am afraid that things will escalate; that people will come onto my property, will they do things to my home, my property, my family.

I am afraid of [REDACTED] and her family. I do not know who they are affiliated with and I don't know what they might do. I would like to assist in prosecution of a crime that occurs from [REDACTED]'s actions.

This statement is true and correct. It was typed for me by Deputy Welch. We have reviewed it together for accuracy and I agree with the contents.
