**NARRATIVE**

On 08/05/2020 at about 2048hrs while on patrol in Shoreline as 4A10, I responded to what was reported as a vandalism located at [REDACTED] Shoreline, WA.

V [REDACTED] lives at the above location with her niece, O [REDACTED] [REDACTED] and [REDACTED] previously reported an incident on 07/20/2020 under case number C20022893 regarding alleged threats from their neighbor, O [REDACTED] [REDACTED] [REDACTED] has been putting "Black Lives Matter" signs in the neighborhood and has been writing "Black Lives Matter" in chalk in the street. [REDACTED] also has been putting "Black Power" signs in the neighborhood and stated that her neighbor "will not silence my Black voice".

Today, [REDACTED] called to report that someone had spraypainted "OLL LIVES MATER" in black paint in a grassy patch at the end of her driveway. [REDACTED] supposes the writing was meant to spell "ALL LIVES MATTER". [REDACTED] stated that she had last seen the grassy patch at about 1900hrs and that there was no spraypaint. [REDACTED] discovered the spraypaint at around 2030hrs.

[REDACTED] wanted to add that on 07/25/2020, [REDACTED] had organized a "Black Lives Matter" march at Paramount Park. [REDACTED] stated that [REDACTED] son, O [REDACTED] [REDACTED] was at the march filming the protesters and was not wearing a mask. When confronted about not wearing a mask, [REDACTED] stated that [REDACTED] became "belligerent" but would not elaborate on what he said. [REDACTED] did not specify that she thought [REDACTED] had spraypainted the message but was adamant that his behavior be documented.

[REDACTED] expressed feeling fearful because of the spraypaint in her yard and stated that she was planning on getting a camera for her house. [REDACTED] stated that she has never felt the need to buy a camera until now.

The spraypaint message may be related to [REDACTED] and [REDACTED] race and has damaged their yard. [REDACTED] supposes that the message may have been written in "retaliation" for the incident she reported previously.

I checked the houses across the street but neither of them had cameras. There is no suspect information at this time, but [REDACTED] stated that she would assist in prosecution.

I provided [REDACTED] with the case number. Sergeant Klein responded to the scene per policy. Photos are on DIMS.

On 8-6-2020 at approximately 0955 hours I was dispatched to speak with [REDACTED] via phone regarding an incident that involving spray paint at [REDACTED] and [REDACTED] residence [REDACTED] (C20024682). [REDACTED] told me that she saw a Facebook post on Black Lives Matter-Shoreline's page outlining the above event. The Facebook post shows a photograph of spray paint on grass reading "OLL Lies (Lives) Mater". This post continues to read "URGENT: PLEASE READ & SUPPORT AN IMPORTANT CALL TO ACTION TOMORROW THURSDAY 8/6 at 10am." The post outlined an incident that occurred a few weeks ago that was documented under C2002893 involving [REDACTED] and [REDACTED]. It goes on to read that the same child [REDACTED] is being harassed by members of the community then reads "(Believed to be affiliated with the same individual who threatened the child)". The Facebook post continued stating there would be a "call to action" for chalking on the street of 9<sup>th</sup> Ave NE between NE 160<sup>th</sup> St. and NE 165<sup>th</sup> St.

Although the post does not list her specifically, [REDACTED] was very upset over this post because of the falsity surrounding the accusation. She let me know she was at her house last night during the time of the event at the [REDACTED] residence. She displayed concern over protestors at the intersection of NE 160<sup>th</sup> St./9<sup>th</sup> Ave NE writing in the roadway with chalk because of previous incidents where she has been the target of random vehicles driving by and occupants screaming "Black Lives Matter". There was also an incident (K20221336) on 7/24 where a vehicle on their property had a tire slashed. [REDACTED] advised the vehicle is not used and they did not want an incident report generated but believe it is somehow connected with the original incident. [REDACTED] stated she was going to move forward with petitioning the court for a court order.

At 1054 hours I was updated by King County Dispatch the neighbor from [REDACTED] 9<sup>th</sup> Ave NE reported that protesters had punched his vehicle (WA/084YNL). I spoke the driver of the vehicle, [REDACTED], who told me he was driving on NE 160<sup>th</sup> St. to get to his significant others house, [REDACTED], and saw the group of protesters. He slowed down to approximately 10 mph as he approached the intersection to make a left turn onto 9<sup>th</sup> Ave NE. He stated the protesters did not block him or surround him but as he made the turn at the intersection he heard banging on his vehicle and noted a couple white males had "punched" his vehicle. He sped up to get away from the protesters and parked his vehicle at [REDACTED]'s residence and went inside. He told me he didn't get a full look at his vehicle but did not see any major damages from the protesters. At 1109 hours King County Dispatch advised of a protester calling into 9-1-1 that an unknown male "gunned" his engine trying to run protesters over and second hand information the same male flashed a gun. I called [REDACTED] back and asked him about the incident again specifically about him flashing an alleged gun. [REDACTED] stated he does not own any firearms of any kind. I attempted to contact the individuals who called in for the alleged display of the firearm and left voice messages with both for follow up when it was most convenient.

**NARRATIVE**

On August 6th 2020 I spoke with two witnesses who stated they were involved/witnessed the incident and wanted to explain their involvement (See Deputy Welch's narrative for further).

I first spoke (W) Corinna Sullivan who stated that she was a member of the protest who observed a Jeep drive "threateningly" towards the crowd of people near the intersection of 160th/9th Ave NE. Corinna said the driver of the vehicle was not cautious for people in the street and that the driver was driving at a high rate of speed towards people in the crowd. Corinna also pointed out that her children who were also in the crowd told her that they believed the driver of the vehicle was trying to hit them. Corinna said that she did not see the driver of the vehicle brandish a weapon but had been told by other people.

I then spoke with another witness (W) Tukwila Jones who stated that she was drawing chalk on the sidewalk at 160th/9th Ave NE when she saw a silver Jeep Loreda (LIC#084YNL) turn left from 10th Ave NE onto 160th St. Tukwila said that she also observed the driver of the vehicle speed up on 160th St and that it looked like the driver was trying to hit people in the crowd. Tukwila said she observed the driver get into his driveway at 15829 9th Ave NE and then walk into his house. Tukwila described the driver as an older white male in his 60s wearing a gray t-shirt, gray shorts and black tennis shoes.

Tukwila said the driver then came back out of his house and lifted up his t-shirt exposing a pistol in his waistband. Tukwila said she did not know what type of gun it was but knew it was a pistol of some sort. Tukwila said the individual did not say anything and then walked back into his house. Tukwila said there were other members who were with her who were livestreaming the encounter and that she would be trying to retrieve footage of the driver brandishing a gun.

According to Deputy Welch's report, the driver of the Jeep Loreda was identified as (O) [REDACTED]. In Deputy Welch's report, [REDACTED] stated that he called 911 because a couple of protesters had punched his vehicle as he turned onto 9th Ave NE and that he sped away to get away from the protesters hitting his car. Don denied any claims that he brandished a firearm in the driveway and told Deputy Welch that he does not own any firearms.

This concludes my follow up and involvement in this case.

Contacted LISA MONIQUE CONLAN who was at the intersection on 8/6/20 during the gathering. She stated she was in the middle of the intersection with a friend and a 5YO boy amongst others in the intersection. She informed me when vehicles would come through the intersection they would slow down, allowing the individuals in the intersection to gather their things and move out of the way. She continued that a silver Jeep was came up the hill on NE 160<sup>th</sup> towards 9<sup>th</sup> Avenue. She said the Jeep accelerated towards her and the 5YO boy. She tried to shield the 5YO with her body and told me she thought "oh my god, he is going to fucking run us over". A friend jumped in front of her along with other protestors and were yelling "slow down". The Jeep then turned left on 9<sup>th</sup> Ave NE and parked his vehicle three houses down from the intersection.

CONLAN stated she heard second hand information from others that had run towards the house the Jeep parked at that a white male had exited the vehicle, walked into his house. The same male then walked out of the house with a gun in hand. He presented the gun to the crowd and raised it against his chest. The male did not point the gun at anyone. CONLAN stated she was not recording the incident but knows a friend who recorded the male presenting the gun to the crowd.

I contacted ANITA WASHINGTON who was also at the gathering along with CONLAN. She explained the same set of events. She stated most vehicles that approached the group would slow down but a gray SUV approached the group pretty fast as if it was going to barrel through the group. She approximated the vehicle was going 35-40 mph almost hitting a couple of people. The event happened really fast and WASHINGTON was not able to get her phone out to record it. WASHINGTON did see the gray SUV park nearby and started to record the male who was driving. She saw him enter his home then come back outside with something in his hand. She heard someone else shout something to the effect of "now you're going to brandish a gun?" She assumed it was a gun but stated it could have been another object.

I am currently waiting for WASHINGTON's video to be made available. Documentation only at this time.
