Primary Incident Report

NARRATIVE

08-07-20/1026 hours: On the noted date/time, FBI Special Agents [redacted] and [redacted] requested assistance from KCSO/Shoreline PD. This request was made thru KCSO dispatch. I called Special Agent [redacted] and he indicated the following:

He received an on-line tip report where JOHNSON was accusing [redacted] and her son [redacted] of threatening to "shoot children" who were participating in a BLM protest in Shoreline. JOHNSON even stated that the [redacted] had access to "firearms" and the report stated they were involved in "mass shooting, bombings, weapon of mass destruction & terrorism". Special Agent [redacted] provided the attached FBI tip-line report.

I explained to Special Agent [redacted] that Shoreline PD has been involved in various investigations involving [redacted] and alleged threats she was accused of making, including "shooting kids", "lynching" a 13 year old named [redacted] and attempting to hit [redacted] with her car. In various social media posts, [redacted] is called a "white supremacist" and a "racist". As of this time, our investigation has shown no evidence that these threats are credible nor where they even made by [redacted] nor [redacted]. We have no evidence that [redacted] nor [redacted] have made any threats to anyone. The incidents have escalated due to the use of "social media". Our investigation shows social media postings which have been used to inflame people and incite activities/practices by BLM and their supporters, which are intended to intimidate the [redacted] family. There is zero evidence that the [redacted] are "white supremacists".

08-08-20/1424 hours: Attempted phone contact with Johnson. Voice mail. I left a message to call me so I can obtain a recorded statement from her.

08-08-20/1446 hours: Contacted KCSO Data Unit. Confirmed both [redacted] and [redacted] have current concealed pistol licenses. [redacted] has no firearms registered. [redacted] does have firearms registered to him. See attached.

08-08-20/1540 hours: Johnson returned my phone call. I obtained a recorded statement (attached) with her permission. Johnson stated she is active in Shoreline BLM but was not present for any incident in Shoreline. All information she reported to the FBI was reported to her by [redacted], who is involved in all incidents noted in this case. Johnson has no first hand knowledge of any threats. [redacted] is also a suspect in a internet cyber-stalking/malicious harassment case under the above case number C20024682.
