	hrs. I arrived at a dispatched call of an assault at 9 A	ave NE, Shoreline, WA. RP-	called on	

As I drove up to this home I saw at 15-20 people out in both the street and on the sidewalks. I saw chalk writings on the public roadway (I did not see what they said at first). I saw two men, RP- and RP and RP flagging me down. As I drove closer I saw some of these people (several females) had cell phones pointed in my direction and they appeared to be filming me.- they did not look friendly having scowls on their faces and stood quite rigidly.

Not being aware of why this was happening and in order to preserve the peace, I asked both RP s to step in to my patrol car (my "office on wheels as I called it). Both RP s did and I drove tabout one block away on 8 Ave NE and spoke to them. If anyone followed us to film us I was not aware of them.

told me that this morning at 0930 hrs. he noticed the chalk writings (which he said had been there, walked away with rain and were written again), now said in bold lettering "Racist" and "Racist Lives Here" with arrows pointing directly to his house. He told me that the entire neighborhood had received letters about his 13 year old neighbor being accosted and general support for Black Lives Matter.

he walked over to his neighbor s at simply to talk to her and find out why someone would proclaim him a racist (which he adamantly denied and seemed hurt). told me that (possibly s daughter), began screaming at him telling him to get off her property (homeowner per KC Assessments is said that he is disabled and doesn t move very fast and that he was walking away when pushed him on his arms, no injury. left the property and later spoke to his son who helped him call police to report this.

it was clear that both had legitimate concerns of harassment by After speaking with both and and even the young 13 year old who lives at the home. We discussed a possible anti-harassment order and I documented this incident.

home (2 houses north of and opened the back doors of the patrol car to help them out, I As I drove both back to could clearly see the "Racist" chalk writing with arrows pointing to house and I now saw several large writings saying "Shoreline Police are Racists". The crowd had thinned out somewhat and now maybe 5-8 people were till outside with one female pointing her cell phone at me looking directly at me yelling "Shoreline Police are Racist!".

to help his father get into his house and not engage or speak to these people. I asked them to take photos of the Racist chalkings to keep in the event they needed an anti-harassment order. As I drove away the female holding the cell phone kept it pointed in my direction and although she kept standing in the roadway she did not try to block me from driving away.

Later in the shift I looked up Black Lives Matter- Shoreline and saw a posted video of RP- trying to leave a yard with an adult female coming towards him and shouting over and over again, "Get out of our yard! Get out of our yard!". Due to postings on fb that can easily be removed by their page administrator, I made a video of this and submitted it to KCSO DIMS.

Also while reading Shoreline Area News I found an "article" by Steve Schneider accusing others of "accosting" a "young Black woman".
