Purpose

- Review financial status of the three primary operating funds of the City after the first quarter of 2007
- Provide an update on any significant financial data that has occurred since the end of the first quarter
- Informational No Action Required By Council





- Street Fund
 - Actual Revenues 3.13% above projected revenues
 - Right-of-Way Fees
 - Actual Expenditures 10.78% below projected expenditures
 - Billings from King County for maintenance and street lights received after end of 1st quarter
- Surface Water Utility Fund
 - Actual Revenues 3.73% above projected revenues
 - Actual Expenditures 39.64% below projected expenditures
 - Primarily related to capital projects

General Fund Highlights

- Revenues 4.99% or \$183,516 above projections
 - Sales Tax above projections by 3.75% or \$39,579
 - Utility Tax & Franchise Fees above projections by 4.18% or \$30,009
 - Natural Gas and Telephone collections greater than projected
 - Water Franchise and Cable Franchise payment not received during 1st quarter
 - Park/Recreation fee revenue above projections by 6.61% or \$15,898

Permit revenue above projections by 11.12% or \$43,179

General Fund Highlights

- Expenditures 2.98% or \$134,777 below projections
 - Contracted services under projections as a result of billings not received during first quarter
 i.e., King County Services
 Difficult to project trends based on first quarter activity

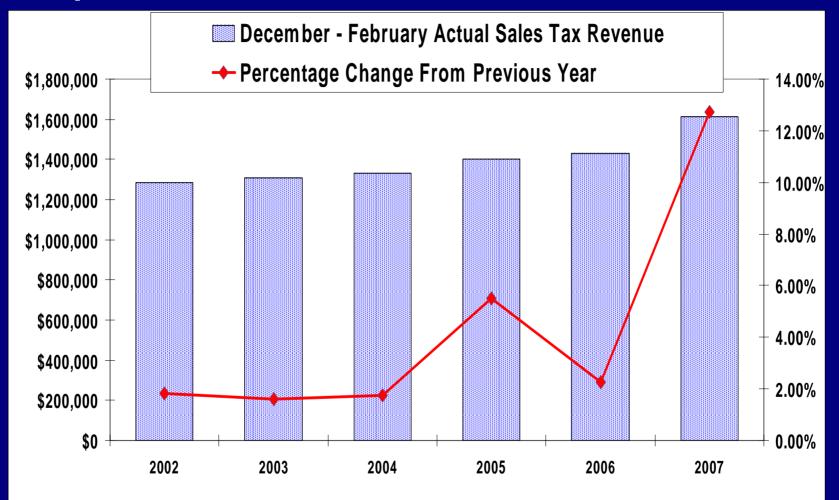


First Quarter Jail Cost Comparison 2003-2007

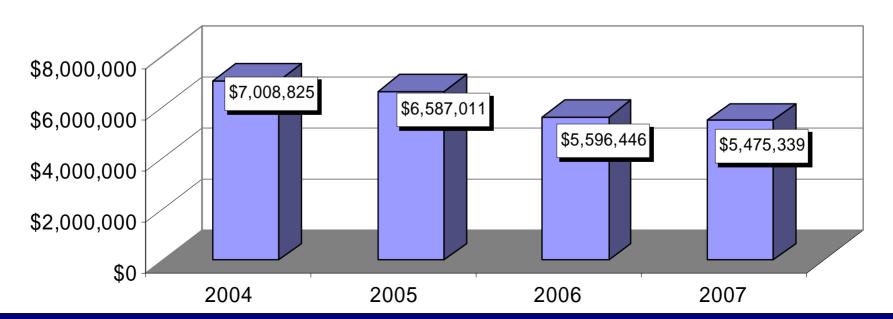

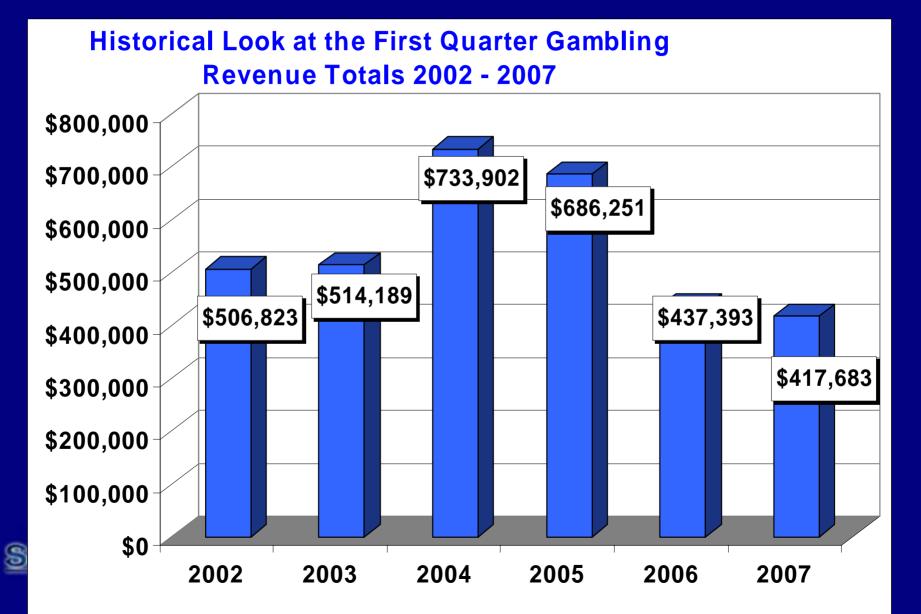
Update on Gambling Tax Revenue First Quarter Activity

- Projected to receive \$438,300, actual revenue equaled \$417,683
 - Card game revenue down by \$9,830 or 2.5%
 - Pull tab revenue down by \$10,755 or 22.8%.

Gross Card Room Gambling Receipts 2004 - 2007

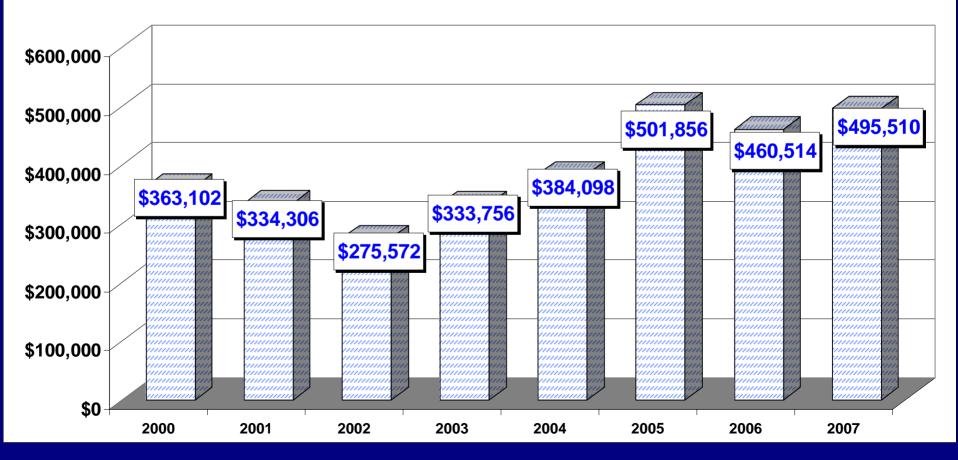


Gambling Tax Revenue
