# CONCEPT MASTER PLAN

This Final Environmental Impact Statement (FEIS) for the Shoreline Community College *Concept Master Plan* has been prepared in compliance with the State Environmental Policy Act of 1971 (Chapter 43.21C, Revised Code of Washington); the SEPA Rules, effective April 4, 1984, as amended (Chapter 197-11, Washington Administrative Code); and rules adopted by Shoreline Community College implementing SEPA. For purposes of SEPA compliance, this FEIS includes the DEIS that was issued for this project. Preparation of this EIS is the responsibility of College's Administrative Services Office. The Administrative Services Office has determined that this document has been prepared in a responsible manner using appropriate methodology and has directed the areas of research and analysis that were undertaken in preparation of this EIS. This document will accompany the *Preferred Alternative* and will be considered in making the final decisions concerning the *Concept Master Plan* and individual projects identified in the *Concept Master Plan*.

#### --PREFACE--

The purpose of this Final Environmental Impact Statement (FEIS) is to provide Shoreline Community College, as well as permitting agencies; an accurate analysis of probable significant environmental impacts that could result from the *Preferred Alternative*, as well as other alternatives that have been evaluated. This document incorporates by reference the analysis contained in the Draft EIS (DEIS), refinements and amendments to the project since the DEIS was issued, and responses to written comments and public testimony that were received concerning the DEIS.

The FEIS is a disclosure document. Based on information contained in the Shoreline Community College *Concept Master Plan*, this FEIS evaluates the direct, indirect and cumulative impacts of the *Preferred Alternative*, several site development alternatives and the *No Action Alternative*. This FEIS, the *Concept Master Plan*, and the DEIS should be reviewed collectively for a comprehensive understanding of all aspects of the proposed project and possible environmental impacts. Since the Master Plan is a conceptual, land use planning document, this FEIS provides programmatic-level environmental impact analysis. Where project-specific information is known, however, the proposed facilities are addressed at a project-level of environmental review.

By its nature, this FEIS does <u>not authorize</u> a specific action or alternative -- nor does it <u>recommend</u> for or against a particular course of action; but rather the FEIS is one several key documents that will be considered in the decision-making process for the *Concept Master Plan*. A list of expected licenses, permits and approvals is contained in the *Fact Sheet* to this FEIS (page *ii*). This FEIS will accompany the applications specifically associated with those approval processes.

The environmental elements that were analyzed in the DEIS for this project were determined as a result of the formal, public EIS scoping process, which occurred January 24, 2003 through February 14, 2003. Comments received during the EIS scoping period were considered by Shoreline Community College in determining the issues and alternatives to be analyzed in the DEIS. Eleven broad areas of environmental review are evaluated, including: earth, water, plants and animals, environmental health, noise, land use/aesthetics, transportation/circulation, and public services and utilities.

The DEIS was issued for a public comment period from July 29, 2003 through August 14, 2003 and a public meeting was held on July 29, 2003. Comments that were received on the DEIS are addressed in this FEIS. Wherever possible, amendments and clarifications pertaining to the DEIS are incorporated into this FEIS. A complete Table of Contents for this FEIS is contained on page *vi* of the *Fact Sheet*. In general, this FEIS is organized into six major sections, as outlined below:

- The *Fact Sheet* (immediately following this *Preface*) provides an overview of the *Proposed Action*, its location, the approvals needed, contact information, and the Table of Contents:
- **Section I** summarizes the description of the *Proposed Action* and the other alternatives, as well as provides a summary of significant environmental impacts, mitigation measures, and unavoidable adverse impacts;
- **Section II** provides a detailed description of the *Proposed Action* and each alternative;
- Section III contains amendments and clarifications to the DEIS:
- Section IV includes key issues issues that were commented upon by several people as part of the DEIS public review process;<sup>2</sup>
- **Section V** contains all written comments that were received regarding the DEIS, together with responses to those comments; and
- **Section VI** includes testimony received at the DEIS public meeting and responses to comments received at that meeting.

The purpose of the public meeting was to provide an additional opportunity for verbal comments – in addition to the submittal of written comments.

The <u>Key Issue</u> section is intended to avoid duplication in responses to similar comments (Section V and VI of this FEIS). Similar issues raised by commenters are addressed in the Key Issue section and the response to the commenter refers the reader to the Key Issue that is referenced – rather than providing duplicative responses to similar comments in Section V and VI.

Location

The campus of Shoreline Community College is located in southwest Shoreline. The campus is generally bounded by Greenwood Avenue N. and Carlyle Hall Road on the east, Innis Arden Way on the south, and City of Shoreline park property on the west and north. The address of the college is 16101 Greenwood Avenue N., Shoreline, WA 98133.

#### **Preferred Alternative**

The purpose of the *Concept Master Plan* is both to guide future development on the campus of Shoreline Community College and to serve as the basis for subsequent approval by the City of Shoreline of an overlay-zoning district for the college. Site-specific development would continue to undergo review by the City.

The *Preferred Alternative* that is evaluated in this FEIS and is the focus of the *Concept Master Plan* includes:

- goals and objectives pertaining to future campus development;
- development program identifying the approximate location and size of all planned development activity (buildings, landscaped open spaces, vehicular circulation/parking, and infrastructure³) that is proposed within each of the four planning periods: (*Projects-in-Progress/Completion* – 2003-2005, *Near-Term* – 2006-2009), *Short-Term* – 2010-2015, *Long-Term* – 2015+);
- building renovation and replacement; and
- proposed campus-wide architectural, landscape and engineering design guidelines.

An estimated net increase of approximately 225,600 sq.ft. of on-campus building space is proposed as part of this Concept Master Plan. Also, it is anticipated that over the life of the Concept Master Plan, the amount of parking may increase by 250 to 380 spaces (net increase). Conceivably, this additional parking would be provided either off-campus at a satellite lot or if funding, project design and environmental factors warrant, additional parking could be located beneath new buildings that are planned proximate to the campus loop road.

The location, configuration and footprint of proposed new development/replacement facilities depicted in the *Concept Master Plan* and this FEIS is based on current estimates of campus needs. While the amount of new development is appropriate to accommodate projected campus needs, the actual location, configuration and footprint of proposed new development — as well as replacement facilities, may change as program needs become better defined. It is expected, however, that the estimated net increase of development will remain essentially as outlined in the *Concept Master Plan* and evaluated by this FEIS.

This FEIS, together with the DEIS, also analyzes the environmental impacts associated with two development alternatives – *Expanded Development Alternative* and a *Modified Design Alternative* — as well as the *No Action Alternative*.
