Meeting Summary

Meeting started at approximately 6:30 pm.

1. Welcome/Agenda Review

Kirk welcomed everyone & thanked them for their attendance. Staff & team members introduced themselves. Kirk introduced Paul Fuesel of KPG and explained that KPG will being doing the design work for the next two mile of Aurora. Kirk reviewed the schedule of upcoming events including the ribbon cutting for the section of Aurora from North 145th Street – North 165th Street and the Interurban Trail bridges on Saturday, June 16; the community open house on Wednesday, June 20 at Meridian Park Elementary School from 6:00 – 8:30 pm; the City Council meeting on July 16, at which the draft recommended alternative will be presented; and the City Council meeting on July 23, at which it is anticipated that the Council will select the preferred alternative for Aurora from North 165th Street – North 205th Street. The final ABC Team meeting will be June 27, which will include a debrief from the June 20th community open house.
